## Myanmar, Bangladesh to cooperate on border security

THE Ministerial Meeting on Border Security and Law Enforcement Cooperation between the Ministry of Home Affairs of the Republic of the Union of Myanmar and the Ministry of Home Affairs of the People's Republic of Bangladesh was held at the Horizon Lake View Hotel in Nay Pyi Taw yesterday. After the ministerial meeting from 9am to noon, the Pre-Coordination Bilateral Meeting on the Senior Official Level was held.

**Discussed at the meeting were strengthening border security, law enforcement cooperation, counter-terrorism, establishing border liaison offices, identification for entry and exit, illegal border crossing, verification of citizenship, narcotic drugs control and repatriation after the verification process for refugees in Bangladesh. Both countries agreed to adopt 10 points of bilateral cooperation between the two ministries.**

The meeting was attended by H.E. Lieutenant General Kyaw Swe, Union Minister, Ministry of Home Affairs, Major General Aung Soe, Deputy Minister, Ministry of Home Affairs, Police Major General Aung Win Oo, Chief of Myanmar Police Force, the Permanent Secretary and Directors General from the Ministry of Home Affairs, Ministry of Defence, Ministry of Foreign Affairs, Office of the State Counsellor, Ministry

of Labour, Immigration and Population, Ministry of Planning and Finance. From the Bangladesh side, H.E. Mr. Asaduzzaman Khan, Minister for the Ministry of Home Affairs, Permanent Secretaries, Director General from the Bangladesh Police, Major General Abul Hossain, Director General of the Bangladesh Border Guard Police and the Senior Officials from the Ministry of Home Affairs.

## Peace is at hand: UNFC

PEACE in Myanmar is "an arm's length away", a member of the group representing armed ethnic groups that have yet to sign the Nationwide Ceasefire Agreement said yesterday.

The Delegation for Political Negotiation (DPN), an association representing armed ethnic groups formed by the United Nationalities Federation Council (UNFC), held its seventh meeting the Peace Commission at the National Reconciliation and Peace Center (NRPC) on Shweli Road in Yangon yesterday morning, after which participants said they are close to an agreement on a comprehensive ceasefire. The revelation was made when representatives from the two sides met with local and foreign media immediately after yesterday's meeting.

The following are the essence of the answers provided by U Zaw Htay of the Peace Commission and Nai Aung Ma Ngay and U Tun Zaw of the DPN. The meeting is centred around an eight-point agenda that specifies certain negotiating points.

The eight-points of the UNFC amendment proposal are:

1. Bilateral ceasefire agreement between the government-military and the UNFC;

# 2<sup>nd</sup> Pyidaungsu Hluttaw 6<sup>th</sup> session 3<sup>rd</sup> day meeting

THE 2nd Pyidaungsu Hluttaw 6th Regular Session held its 3rd day meeting at the meeting hall of the Pyidaungsu Hluttaw in Nay Pyi Taw yesterday morning.

On the matter of using Ks28.14 billion from the emergency fund of the 2017 Union Budget Law sent by the President, Deputy Minister for Electricity and Energy Dr Tun Naing said the Ministry of Electricity and Energy is implementing works to provide electrical power to meet increasing usage as well as to deliver electrical power to far-off places where ethnic nationals live.

These works includes the 230 KV and 66 KV transmission line and substation projects that will support the socio economic development of ethnic Rakhine nationals. Starting from December 2014, 155 villages in 11 townships of Sittway, Ponnagyun, MraukU, Kyauktaw, Kyaukpyu, An, Yanbye, Thandwe, Ngapale, Taungup and Maei were provided with electricity.

As for now, with an aim for regional security and development in Rakhine State, there is a requirement for 65.03 miles of power line along Ponnagyun, Yathedaung, Buthidaung and Maungtaung and three 66 KV substations to provide 24 hours electricity to the remaining townships of Yathedaung, Buthidaung and Maungtaung townships. The plan is to supply electricity by completing 22.6 miles of 66 KV Ponnagyun-Yathedaung power line and Yathedaung substation on March 2018, 33.5 miles of 66 KV Yathedaung-Buthidaung power line and Buthidaung substation on June 2018 and 8.93 miles of 66 KV Buthidaung-Maungtaung power line and Maungtaung 66 KV substation before end 2018.

An estimated Ks30.35 billion

will be used for the 66 KV power lines and substations projects. Ks4 billion for the 66 KV power line and substation to be constructed in this fiscal year were being applied to be included in the emergency fund. Once the hluttaw approves the request for emergency funds, construction work will be implemented quickly, said the Deputy Minister.

Once these 66 KV power line reach Buthidaung and Maungtaung, Ks5.75 billion had been requested from the emergency fund to connect 17 villages in Yathedaung Township, 11 villages in Buthidaung Township, 15 villages in Maungtaung Township totalling 43 villages with 107 miles of 11 KV power line, 45 miles of 400 volt line and construct 53 units of 11/0.4 KV 100 KV transformer as well as to transport and install a 300 KVA diesel generator in Zedipyin Village, Yathedaung Township.

A maximum of about nine months is required for tendering, material collection and construction of these works. A request for emergency funds was made as these works are to be completed by March 2018. Once these works are completed Yathedaung, Buthidaung and Maungtaung towns as well as 44 nearby villages will have 24 hours electricity and will support the regional security and develop-

ment and thus the request for an emergency fund was made said the Deputy Minister.

Union Minister for Social Welfare, Relief and Resettlement Dr. Win Myat Aye and Deputy Minister for Construction U Kyaw Lin then explained further about using Ks281.36 billion from the emergency fund.

Next, Pyidaungsu Hluttaw Speaker Mahn Win Khaing Than announced Hluttaw putting on record the allocation of Ks281.36 billion for four works: one for Ministry of Electricity and Energy; two for Ministry of Construction and one for Ministry of Social Welfare, Relief and Resettlement.

## Refilling the deficit of the State Budget

U Maung Maung Win, Deputy Minister for Planning and Finance said, "Refilling the deficit of the State Budget with local and foreign loans is a procedure exercised by global countries. In Myanmar also, successive governments refilled additional budget deficits with local loans after calculating foreign loans and subsidies. Previously as well, annual loans were received from the Central Bank of Myanmar, but it was decided and managed by the Government only. Now, if the the Central Bank of Myanmar wants to lend money to the

Government, the Central Bank of Myanmar has to lend the money with the approval of Pyidaungsu Hluttaw under section 91 of the Central Bank of Myanmar Law, hence the submission to Pyidaungsu Hluttaw for the Central Bank of Myanmar to get the approval of the Hluttaw."

He added, "Borrowing money from the Central Bank of Myanmar will not affect directly making the monetary volume and national circulation money amount increase directly, but rather indirectly. However, getting loans from external institutions can directly affect making monetary volume and national circulation money amount reduce. For this, to refill the deficits of the Union Government's Allocation Account for FY 2017-2018, the programme to borrow Ks1.2 trillion from the Central Bank of Myanmar was put forward so that it can be approved."

In regard to the submission, U Soe Thein, Deputy Governor of the Central Bank of Myanmar continued to discuss.

Following that, the Speaker of the Pyidaungsu Hluttaw got the decision of the Hluttaw by the use of buttons for voting, announcing that Hluttaw approved the matter with 568 votes in favor, 5 votes against and 5 failures to vote. Afterward, U Soe Thein clarified concerning the report of

implementation of monetary policy, FY 2015-2016 and the report of stability of monetary system, followed by the announcement that Hluttaw put on records, discussions of Hluttaw representatives and clarifications of the CBM including the reports.

In addition, U Hset Aung, Deputy Minister for Planning and Finance explained about the report of performances of Myanmar Investment Commission from 1st April 2016 to 31st March 2017.

After that Speaker of Pyidaungsu Hluttaw announced the approval of clarifications of the respective Union-level organization member and discussions of parliamentarians including the report of the performances. Then parliamentarians discussed concerning Myanmar's signing BIM-STEAC Convention sent by the President of the State.

Concerning for Myanmar to sign the third multi-lateral investment treaty's amendment, Daw Htu May of Rakhine State constituency 1 said: "The treaty was signed in February 2009 and approved on 29th March 2012, with a view to creating a free, frank, smooth, transparent and competition-accessible environment in ASEAN region and strengthening the benefits of investors based on ASEAN region. ASEAN Multi-lateral Investment Agreements are of great importance for ASEAN circle, and Myanmar. As the ASEAN Economic Community, different types of South East Asia was designed to become a Single Market, become a strong competitive economic zone, upgrade fair economic development in the region and to take part in global economy. Multilateral Investment Treaty should be assessed in comparison with economic policies of ASEAN countries."

Speaker of the Pyidaungsu Hluttaw announced the approval after taking the decision of Hluttaw. ■

## UNFC to sign NCA after breaking last deadlock on November-8

FOLLOWING the second day of the 7th meeting in Yangon yesterday, the Peace Commission and the Delegation for Political Negotiation-DPN of the United Nationalities Federal Council-UNFC are hoping to sign the Nationwide Ceasefire Agreement after both breaking a last deadlock on November-8 meeting.

“Most of the eight points we proposed have been agreed by both sides. But, for number 5th-point, we need to negotiate with the Tatmadaw personnel and also in DPN side. After that, we will negotiate again with the PC on November-8 meeting,” said Nai Aung Ma Ngay, deputy leader of the DPN.

Signing the NCA is the ninth-point comes after eight points proposed by the UNFC.

“Current level both sides reach today is not the level of debating, but the level of commitment made by both sides to

overcome the challenge. The best situation,” said U Zaw Htay, representative of the Peace Commission.

Regarding the proposed No. sixth by UNFC to include international observers in Joint Monitoring Committee, both sides agreed to move forward in the form of the JMC Support Platform.

The JMC Support Platform will be implemented following the NCA signing with UNFC.

The peace makers will review strong and weak points of the Joint Monitoring Committee next week at the NRPC in Yangon as a step toward better peace process.

In the first day meeting on Monday, DPN proposed a better way for discussion to UPDJC in order that both sides can move forward with a new way which is believed to be better than current one. —Ye Khaung Nyunt ■

# Stimulant tablets and opium seized

Similarly, authorities seized 5,000 stimulant pills and Ks33,000 from Zaw Naing Htway, also known as Fatty, Thiha Maung and Sai Thura Naing, also known as Ko Sai, while searching Hollywood KTV on 35<sup>th</sup> Street between 60<sup>th</sup> and 62<sup>nd</sup> Street in Nagar Ward, Chanayethazan Township, Mandalay on the evening of 22 October: On the same evening at about 10pm, a police squad searched a passenger bus at the Thaze combined inspection gate in Kalaw Town and found 20,000 stimulant tablets and a hand phone in Myo Zaw Lwin's luggage.

Police have taken action against them under the Anti-Narcotic Drugs and Psychotropic Substances Law. —Myanmar Police Forces ■

## MRF to conduct short and long-term projects for development of rice sector in Rakhine State

THE Myanmar Rice Federation (MRF) will set up short and long-term projects in an attempt to effectuate the development of the rice sector in Rakhine State, said U Ye Min Aung, the general secretary of MRF.

The paddies in Rakhine State are due to be harvested next month, but many paddy owners fled, were captured or killed following the terrorist attacks of 25 August. For the same reason, the paddies also lack labourers, which would mean damage or destruction of crops due to neglect. Therefore, the MRF has stepped in and will concentrate on dealing with this time-sensitive problem.

“There are 30,000 to 40,000 acres of paddy each in Buthidaung, Maungtaw and Yathedaung townships. As a priority activity, we will provide grain machines, tractors and grain dryers. We will sell the fertilizer at a cheap cost. Also, we will purchase the paddy, setting a price,” said U Ye Min Aung.

“We will carry out the activities under the supervision of state government. It is better that the government handles ownerless farms, as this might raise unnecessary accusations when the owners emerge. We will help harvesting activities for farms which have owners”, he said.

In a bid to help develop the

agriculture sector, the MRF will open Agribusiness Services centres in the Kyauktaw, Sittway and MraukU areas within three years, providing contract farming and seed production drying storage and processing, fertilizer and agrochemicals and farm mechanisation service.

Additionally, the MRF will

also establish Agri Food Park on 500 acres of land in Buthidaung Township for value-adding to agro products. In addition to the rice sector in Rakhine State, the MRF will study the production of other crops and the livestock sector. Then they will conduct a feasibility study with international organisations that will determine in

which sector investment is best.

To implement those activities, the MRF will organize Rakhine Agribusiness Public Co. (RAPC) by end of this year. About Ks50 billion is allocated to be spent on RAPC, with capital from MRF and local and international loans. Those activities are meant to support the Union Enterprise for Humanitarian Assistance, Resettlement and Development in Rakhine (UEHRD) led by State Counsellor Daw Aung San Suu Kyi. The MRF cooperates in the development of the rice sector, said U Ye Min Aung.

“Dependency culture is good for a brief period. We need to make investments in capital goods and infrastructure in order to effectuate the development in this sector”, he added.

Beyond self-sufficiency, Rakhine State’s rice is sent to other areas. There are around 1 million acres of rain paddy plantations, whereas only 10,000 acres are found during summer paddy season due to the lack of irrigation projects from dams and rivers. ■

## Japan investments in Myanmar: \$717 million and counting

SINCE the 1988-89 fiscal year, Japan has put foreign direct investments of an estimated \$717 million into Myanmar with 96 projects, according to the Myanmar Investment Commission. The fiscal year of 2015-2016 marked the highest amount of investment with \$219 million.

The manufacturing sector at Thilawa Special Economic Zone has drawn Japanese investments totalling \$183 million so far.

The 13th Joint Meeting of the Japan-Myanmar Business Cooperation Committee between the Union of Myanmar Federation of Chambers of Commerce and Industry (UM-FCCI) and the Japan Chamber of Commerce and Industry was held last Monday.

At this meeting, U Zaw Min Win, the chairman of UM-FCCI, invited Japanese businessmen to invest in agriculture,

livestock, offshore fishing and small- and-medium sized enterprises.

Moreover, he suggested that investments in electric power generation, transportation, inland and international port construction, and technology are likely to reap the most benefits.

Mr. Yoichi Kobayashi, chairperson of Japan-Myanmar CCI Business Cooperation Committee, said that Japanese entrepreneurs are interested to invest in Myanmar, but Myanmar still lacks adequate economic infrastructure. Union Minister U Kyaw Win for Planning and Finance remarked that FDI statistics showed Japan’s investment in Myanmar is still weak.

“We expect this meeting will find a way to promote Japan’s investments”, U Kyaw Win said.

Bilateral trade between Ja-

pan and Myanmar in the first five months of the current fiscal year has reached over US\$756 million, comprised of exports worth about \$360 million and imports worth \$396 million, according to the Commerce Ministry.

Myanmar’s edible oil crops, rubber, green grams, sesame seeds, rice and broken rice, honey, fishery products and apparel from the garment sector using the Cutting-Making-Packaging (CMP) system are exported to Japan, while capital goods such as machinery, intermediate goods such as raw materials and consumer goods from Japan are imported into the country.

Bilateral trade values were about \$2 billion in 2016-2017 FY, \$1.8 billion in 2015-16 FY, \$2.3 billion in 2014-2015 FY, \$1.8 billion in 2013-2014 FY, \$1.5 billion in 2012-2013 FY and \$822 million in 2011-2012 FY. — Ko Htet ■

# SMEs and Variety of Myanmar Business



ACCORDING to the statistics of the SME Development Department, the Ministry of Industry, SMEs occupied 90 percent of the businesses which are driving Myanmar economy, at a conservative estimate, and its job creations amounted to 99.6 percent.

SME, that is, Small and Medium Sized Enterprises play an important role of the national economy and it is also a major driving force of the development. Moreover, it is occasionally called the industry that can bring about social development of equality.

SMEs include farmers, growers, producers, wholesalers, retailers, those who transport these produce and products and the ones who give services concerning these, for the goods to reach consumers in their respective sectors along with "Supply Chain."

On the nation-wide scale, there are 48,778 privately-owned SMEs registered at the Department of Industrial Supervision and Inspection, the Ministry of Industry, out of which 6,651 exist in Yangon Re-

gion, the top of the totem pole. At the department, enterprises have been categorized into 13 sectors—foodstuff, textile, lodging, house-hold utensils, literature and artistic industry, raw material industry, mineral process and production, agricultural and farming equipments, vehicular manufacturing, electrical equipment production, general industrial workshops. Among them,

foodstuff industry reached the top of the registration. The statistics of the industrial supervision and inspection department, under the Ministry of Industry shows that it outnumbered 58.5 percent of all registered industries.

## Opportunity for SMEs

Myanmar is rich in nat-

ural resources, and hence job opportunities may increase by producing them into high-valued products through the uses of modernized techniques. Now that economic unification among global countries became an opportunity, Myanmar has opportunities for SMEs to develop due to more access to Global Supply Change, which is the process of global production, trade and services,

with the establishment of Myanmar-ASEAN Economic Community.

## Challenge for SMEs

Challenges and difficulties coincide with advantages in launching SMEs. U Pyi Nyein, Manager of Business Development, Thuriya Win Company which produces "Flying Dragon Tea Leaves" said, "Acquisition of power supply was a major problem for us in manufacturing dried tea-leaves. Yet, later on we have already had power supply to some extent. As we use oil for power generator and electricity alternately, it costs us much less than ever. But, compared to cost in other countries, we cannot compete them in prices due to our overhead cost. For example, supposing that it will cost K 200 for one kilogram in Vietnam, it will cost in Myanmar K 400 per one kilogram. That is why it is difficult for us to compete with

them."

Difficulty to acquire monetary capital and technical knowhow, weakness to penetrate into local and international markets, lower standards in skills on production, inability to get news and information with changing times, weakness of departments which will help in servicing for economic development, lack of infrastructures, weakness in creating fundamentals of potential de-

duction so as not to meet supply shortage, poor knowledge and skills in package sector, little knowledge on market economy."

## Strengthening Local Market

Exotic imports, especially foodstuffs have advantages as they are produced much under the nature of market competition production cost will be much lower and they can be distributed more broadly than local products.

Local products are being produced only a few numbers, so their production cost will be great. Even though they are equal in quality with exotic imports, local products cannot compete with foreign ones. Nearly it must be said that survival of most of internal

SMEs wholly depends upon over 50 million people of the nation.

Moreover, under the current situation while the country is trying to link with global markets, it is a matter of great importance for SMEs in the nation to hold strong places in local markets too.

Some say that the plan must be promptly implemented so that Myanmar consumers use Myanmar products in trust. But they assert that it cannot be performed SMEs alone.

Only if policy-makers use skills on manipulation of the process and simultaneously economic enterprises which are leading in local and foreign markets help by cooperating wholeheartedly, for successful implementation of the process, will local SMEs be able to get strong markets internally and promptly develop as hoped.

2. To build a federal union with result achieved from 21st Century Panglong Conference (21CPC);
3. Agreement of tripartite dialogue composition;
4. Drafting and promulgation of constitutional law based on the outcome of 21CPC;
5. Advance agreement on Military Codes of Conduct (CoC) and monitoring on Terms of Reference (ToR);
6. Formation of military Joint Monitoring Committee (JMC) with representatives from government, EAOs and international figures acceptable to both parties;
7. Formation of a neutral, enforcement tribunal for NCA involving domestic and international law experts and judges that are acceptable to both parties; and
8. Developmental projects to be tackled according to Extractive Industries Transparency Initiative (EITI), in cooperation with the public and the EAOs. (Source: UNFC Documentation)

**Q: Please explain to the people the outcome of today's meeting.**

Naing Aung Ma Nge: Number five, the basis for a solution, is achieved. Number six is very close to being agreed upon. For number seven, only a few points are left for it to be concluded. Looking at these eight points, two thirds have been overcome.

We are within an arm's length away. Discussions with the Peace Commission had reached an encouraging stage for the peace process. We will soon reach the time (destination) we are expecting to reach.

**Q: What is the result and status of the meeting?**

Naing Aung Ma Nge: Today's meeting is not completed yet. It is hard to estimate how much it will be completed tomorrow. Proposal number five under discussion is still not concluded. It doesn't mean it is far from being concluded. Basic agreements were reached. We only reached number seven now.

**Q: What is your view on today's meeting?**

U Tun Zaw: We start discussing from number five. One to four was completed in the sixth meeting. Five is about format and JMC (Joint Monitoring Committee). On policy matters and programmes in implementing deployment of forces, some titles (subjects) remain (to be discussed) and a proposal was made to conduct this in a joint

session format with the participation of responsible personnel. In the current meeting, the Tatmadaw side is not ready to discuss in a joint session format. On our side, we provided the titles to be discussed. We discussed five. After six, we reached seven. Negotiations will continue tomorrow. In today's meeting, we were able to discuss some parts in detail. It can be said as discussing parts we disagreed on in order to agree. We could not exactly say how many remains from the eight points that are being discussed. There is still a day left to discuss.

**Q: Which number is having difficulty?**

U Zaw Htay: It could not be said a certain number is having difficulty. We are going along the DPN path. Groups that had signed the NCA are reviewing the implementation. After the second anniversary of signing the NCA on 15 October, the government side discussed with PPST (Peace Process Steering Team) leaders and advisers. Both sides were reviewing the shortcomings in implementing the NCA. On Octo-

ber 25, 26 and 27, we will discuss with NCA signatory groups. What I mean is there is two parts in our country's peace process. One part is ceasefire and another part is political discussion. It is the first experience for both. There are ToR (terms of reference) and CoC (code of conduct) that were drawn up with (each group's) own ideas. When it is implemented, there are some that will work out but in some, when political discussion is conducted, may not be as ToR. It will have to be adjusted as time goes by. Discussion was made with the DPN on the first eight proposed points. When these are agreed upon, the NCA will be signed as point number nine. We are repeatedly discussing these nine points. We reached a stage of agreeing in principle. After agreeing in principle, we discuss in detail the worries of both side.

This discussion is truly required. Only when everything is completely discussed can there be no problem (when implemented). We are taking time on this.

**Q: What is the difficulty of**

**both sides and what is the policy difficulty?**

U Zaw Htay: There are two parts from the government side. There are ethnic armed groups that had signed the NCA. There are groups like UNFC that are still discussing. The opinion of the NCA signatory groups had to be considered. The idea of international participation was under consideration for discussion in JICM. Implementation in review is also included. On policy, Tatmadaw and the government's view is a peace process based on NCA. This was also officially announced. Thus, it could not deviate or go beyond NCA. When exact agreements are wanted, we have to make sure it is not deviating or going beyond the NCA and this is causing some delay. All is going along with the peace process. The main destination is federal democracy and (we believe) it will be achieved.

**Q: Is there a plan to be flexible on the eight points proposed by the UNFC?**

U Tun Zaw: There is nothing that the UNFC is holding on to. In the sixth meeting, one to four was completed. All was not completed in a way the UNFC wanted. We have made many concessions. But concessions need to be made by both sides. It could not be one-sided. In discussion of points five to eight, both sides needed to make concessions and come to an equilibrium point. Once this equilibrium point is reached, we will reach the aimed destination.— Myanmar News Agency ■

## Create rural jobs for youths to stem flight to cities, says UN

INDUSTRIAL and service sectors in South Asian and African cities have not grown enough to meet the demand, and won't absorb the millions of new job seekers wanting to escape grinding poverty and hunger in their rural homes, says a report.

Young people growing up in rural Africa need jobs where they live, so they are not forced to join the growing ranks of poor seeking work in cities or to make dangerous journeys to reach Europe, the United Nations' food agency said on Monday.

By 2030, there will be about 1.3 billion 15 to 24 year olds on the planet, some 100 million more than in 2015.

Most of that increase will be in rural areas of sub-Saharan Africa, the U.N. Food and Agriculture Organization (FAO) said at the launch of its annual State of Food and Agriculture report.

Industrial and service sectors in

African and South Asian cities have not grown enough to meet the demand, and won't absorb the millions of new job seekers wanting to escape grinding poverty and hunger in their rural homes, FAO said.

“In Africa, every year 10 to 12 million youths join the labour force, but we have only been providing about 3

million jobs ... So it is not a surprise that they try to cross the desert and the Mediterranean looking for a better opportunity,” said FAO director-general José Graziano da Silva.

Rural areas are not doomed to be poverty traps and could thrive with more invest-

ment in farming and food industries and better infrastructure linking farms and rural businesses to meet the rising demand for food in cities, the report said.

“People can get out of poverty even if they stay in rural areas,” said Marco Sanchez-Cantillo, acting director of

FAO's Agricultural Development Economics Division. “There are parts of the world where rural transformations have lifted hundreds of millions of people out of poverty,” he told the Thomson Reuters Foundation.

Countries in East and Southeast Asia have been able to boost incomes in both cities and the countryside in the past 20 years.

“In Vietnam most of the rural poor have exited poverty while staying in rural areas ... Latin America has many examples too,” he said.

As urban populations grow, so will their demand for food, so farmers need to produce more at a time when climate change is bringing erratic rains and af-

fecting crops in many parts of the world, the U.N. agency said.

Currently 80 percent of food in sub-Saharan Africa and Asia is produced by small-scale farmers, according to FAO. With the right kind of investment in rural infrastructure and farming, young people could find jobs on farms but also in food processing, transport and storage.

In June, several African governments pledged to restore degraded land, invest in agriculture and create “green jobs” for young people in a drive to reduce unemployment, fight radicalisation, and stem the tide of migration to Europe.—Thomson Reuters Foundation ■

## Voices from meeting between Myanmar and Bangladesh

**U Kyaw Zeya, Permanent Secretary of the Ministry of Foreign Affairs:**

“Both sides mainly discussed establishing the border liaison offices, promoting information exchange and understanding between the two countries and formation of joint working groups. Our side mainly discussed going through the process step by step, especial-

ly in the information exchange sector. We also discussed the agreement between Myanmar and Bangladesh signed in 1992 and four agreements between immigration official level meeting between the two countries in 2000.

**U Tin Myint, Permanent Secretary, Ministry of Home Affairs**

Both sides discussed matters related to solving amicably the issues of the rule of law, security and drug trafficking and border issues. Our meeting also touched on the issue of repatriation of refugees who fled from Myanmar to Bangladesh following the attacks by ARSA terrorists. The meeting also focused on solving the bilateral issues in accordance with international rules and regulations because both are neighbouring countries. The repatriation issue would be discussed by the State-level meeting. I can not say how many people would be repatriated, but that would be carried out based on the National Verification process of the Immigration and Population Ministry.

Both sides also agreed to cooperate in fighting terrorism and opening border liaison offices, especially in Maungtaw and the border areas, fighting illegal migration through borders, and fighting drug trafficking.—Kyaw The Ein, Kyaw Hteik Soe ■

# Yangon General Hospital receives YHT Commemorative Blue Plaque

THE prominent Yangon General Hospital in downtown Yangon received a commemorative Yangon City Heritage Blue Plaque on Tuesday.

This Blue Plaque marked 19th plaque of the Yangon Heritage Trust.

The city's first General Hospital, located across the street

at the site of Junction City Complex, had become too cramped for the number of patients it was treating, and thus by the early 1890s, the present site of Yangon General Hospital, which was then Agri-Horticultural Gardens and a Phayre Museum, had been scouted for relocation.

With plans drawn up by Henry Hoyne-Fox, Executive Engineer of the Public Works Department,

the main building was built in 1904 and completed in 1909, and fitted with all the latest modern medical improvement at that time, including operating theatres with electricity and anesthesia rooms. In the following year, the administrative block and other structures such as the Matron's accommodation and the morgue were added and cost four million rupees overall.

In 1911, the new and larger hospital opened its doors for the first time with a total of 342 beds. It also housed the country's first bacteriological laboratory, though which several contributions to global medical science

were made during the early 20th century.

During the Japanese Occupation, the Imperial Japanese Army occupied the building and reserved them for Japanese personnel and the General Hospital had to temporarily relocate to the former Diocesan Girls' School on Signal Pagoda Road. After the World War II, the hospital's capacity was expended to hold 546 beds and in 1962, the total capacity increased to 1500 patients.

"Yangon General Hospital is located in the heart of Yangon as a grandeur of the city. Installation of blue plaques at the heritage buildings in Yangon would en-

courage the people to learn the history of the city, said U Thurein Aung, Project Manager of the YHT. Additionally, Rangoon General Hospital played a huge part in Myanmar's contemporary history, witnessing some of the pivotal moments in the history of the city. The hospital was also the site where the former opposition leader and Noble laureate Aung San Suu Kyi made her first public speech on August 24, 1988.

The commemorative Blue Plaque is a part of Yangon Heritage Trust's efforts to highlight historical buildings and renowned residents who contributed to the narrative of the city. ■



## Tatmadaw releases statement on Rakhine terrorist attacks

THE Tatmadaw released a statement yesterday regarding the terrorist attacks of 25 August by the Arakan Rohingya Salvation Army (ARSA) on police outposts in which dozens were killed and which prompted hundreds of thousands to flee northern Rakhine, saying the attacks were meant to intentionally harm national security and turn global sentiment against the country.

"As regards the terrorist attacks by extremist terrorists who had already been in Rakhine State which took place on 25th August, 2017 in Buthidaung and Maungtau region, Rakhine State, there had been news releases based on false news and allegations over Myanmar made by some international communities and countries and some foreign media very recently", read the statement released by the Tatmadaw True News

Information Team.

The statement went on to say that the attacks were well-planned by thousands, not hundreds, of terrorists.

"In actuality, some 4,000 ARSA extremist terrorists conspired to violently attack 30 police outposts and a military camp simultaneously, and behind the events there had been very complicated background history, hence the need to be well convinced beforehand.

"On 8th June 2012, a Rakhine national girl named Ma Thida Htwe was raped and killed by four Bengalis in Yanbye township, Rakhine State. It caused conflict and on 9th October 2016, Bengali terrorists made violent surprise attacks on border guard forces and three police outposts simultaneously. On 25 August, as the Commander-in-Chief of the Defence Services went

abroad, the Deputy C-in-C of the Defence Service called on the President of the State and the State Counsellor to get instructions regarding the Rakhine State affair. On 4 September, the Commander-in-Chief of the Defence Services met with the State President to receive instructions on Rakhine State affair."

The Tatmadaw statement said security forces were repeatedly reminded to stay within legal bounds when engaging with the terrorists and dealing with civilians.

"In the events of the ARSA extremist terrorists' attacks, security forces who were performing the tasks of defending the national populace living in the region, maintaining the peace and stability of the region and rule of law were instructed, depending upon situations on the ground, to be very mindful of the

rules of engagement concerning armed conflicts and terrorist attacks. They were also instructed to abide by the criminal code in dispersing mobs, and to use self-defense tactics in fighting against terrorists over innocent civilians and security forces. The security forces kept to the rules and regulations.

"At the time of outbreak of the terrorist attacks, local residents and national people who were very frightened were helped in evacuating to safer places, regardless of race and religion. And those displaced people were supported with provisions and they were given medical treatments by mobile health teams. Provisions and humanitarian aid donated by people and communities across the nation were delivered by Tatmadaw helicopters, vessels and motor vehicles.

"Union Government, the Ministry of Social Welfare, Relief and Resettlement and the Rakhine State Government are performing the task of delivering humanitarian aid to the people in need, hand in hand with the Tatmadaw".

The Tatmadaw statement said it is important to view the attacks as an intentional disruption of national security and undeserved accusations of rights violations.

"Concerning the events of ARSA extremist terrorist attacks which took place in northern Rakhine State, it is necessary to take special surveillance over potential destructive performances which can intentionally harm national security and interest, on the wrong pretext of human rights and humanitarianism", the statement said.—Myanmar News Agency ■

# Maungtaw officials conduct field trip to resettle ethnic national villages

CHAIRMAN of Maungtaw Township Management Committee U Myint Khaing and party conducted a field survey trip to survey land on which to build ethnic national villages that were burnt and destroyed during the extremist terrorist attacks by the Arakan Rohingya Salvation Army (ARSA). Next, Maungtaw Township Management Committee chairman and members went to Thitone-nar Gwasone village tract,

## Baltic Fleet corvettes on long-distance voyage pass through English Channel

KALININGRAD — The Russian Baltic Fleet's corvettes Boiky and Soobrazitelny currently on a long-distance voyage have passed through the Dover Strait and the English Channel and entered the Atlantic Ocean, Fleet spokesman Roman Martov told TASS.

"The Baltic Fleet's warships have successfully passed through the Strait of Dover and the English Channel, which

are uneasy for passage in fall, and have entered the Atlantic Ocean," the spokesman said.

The corvettes' crews replenished fuel stocks in the north Atlantic and held the warships' planned inspection. For this purpose, the sea tanker Kola making part of the naval group was involved.

In addition, the corvettes' combat teams practiced joint search for notional enemy's subma-

rines as part of the drills to organize anti-submarine warfare defense while on the move in the Atlantic.

As was reported earlier, the corvettes Boiky and Soobrazitelny, and also the tanker Kola left the naval harbor of Baltiysk on 14 October. Kamov Ka-27PS anti-submarine warfare helicopters are aboard the corvettes along with marine infantry units that have undergone special training.—Tass ■

## Apple, Samsung face new iPhone damages trial — US judge

LOS ANGELES — A US judge has ordered a new trial to determine how much Samsung Electronics Co should pay Apple Inc for copying the look of the iPhone.

US District Judge Lucy Koh in San Jose, California issued her order late on Sunday, 10 months after the US Supreme Court set aside a \$399 million (£302.3 million) award against Samsung, whose devices include the Galaxy.

The three Apple patents covered design elements of the iPhone such as its black rectangular front face, rounded corners, and colourful grid of icons for programmes and apps.

Koh's order is a setback for Apple, which called a retrial unneces-

sary and said the award should be confirmed. The Cupertino, California-based company did not immediately respond on Monday to requests for comment.

Silicon Valley has closely followed the 6-1/2-year-old case.

Companies such as Facebook Inc and Alphabet Inc's Google have said an Apple win would encourage owners of design patents to sue for huge, unfair awards on products containing hundreds of features that are costly to develop.

The \$399 million represented profit from Samsung's sales of infringing smartphones, though the South Korean company has said it deserved reimbursement if it prevailed in the litigation.

It was part of a \$548 million payment that Samsung made to Apple in December 2015.

The legal dispute concerned whether the "article of manufacture" for which Samsung owed damages included its entire smartphones, or only parts that infringed Apple patents.

Without deciding that question, Justice Sonia Sotomayor wrote for the Supreme Court last 6 December that "the term 'article of manufacture' is broad enough to embrace both a product sold to a consumer and a component of that product."

In Sunday's order, Koh said the jury instructions at the original 2012 trial inaccurately stated the law on that issue.—Reuters ■

# Mugabe would have rejected WHO role, says spokesman after its U-turn

HARARE — Robert Mugabe would have rejected the role of World Health Organization goodwill envoy had he been formally asked, his spokesman said on Tuesday, days after state media cheered the Zimbabwean president's appointment.

WHO Director-General Tedros Adhanom Ghebreyesus named Mugabe

as a goodwill ambassador on Wednesday at a conference in Uruguay that both men were attending.

But the appointment was rescinded on Sunday following a backlash from Western donors, rights groups and opposition parties. Last Friday, the state-owned Herald celebrated the largely ceremonial appointment as a

'New feather in President's cap', adding that Mugabe, 93, had accepted the role.

His spokesman told the same newspaper on Tuesday that Zimbabwe's sole leader since independence from Britain in 1980 had only heard about the appointment via the media.

"Had anything been put to the President ... (he) would have found

such a request to be an awkward one," Charamba was quoted as saying. "The WHO cannot take back what it never gave in the first place, and as far as he is concerned, all this hullabaloo over a non-appointment is in fact a non-event." Charamba did not respond to calls seeking further comment. Mugabe's critics were outraged

by Tedros' announcement, saying he was rewarding a man whose government had presided over the collapse of Zimbabwe's health system. Charamba said the fact that Zimbabwe was a producer and exporter of tobacco, mostly to China, would have meant Mugabe campaigning against a crop that underpins the economy. Tobacco is Zimbabwe's

single largest foreign currency earner, bringing in an average \$800 million annually in the last four years, according to official data. "To be seen to be playing goodwill ambassador in respect of an agency which has a well-defined stance on tobacco growing and tobacco selling, that would have been a contradiction," Charamba said. —Reuters



Two fractures, one surgery but not that bad.


"Got to learn some amazing dance moves.

## David Letterman, celebrated late-night TV host, receives US humour prize

WASHINGTON — David Letterman, a pioneering entertainer who was the longest-running host of late-night TV in US history, was honoured on Sunday for his contributions to American culture.

After-hours television was built around the set-piece interview and guest appearance when Letterman's "Late Night" broke the mould in 1982 with absurd pranks and send-ups.

Everyday viewers went on his show to present "stupid pet tricks." Behind his desk, Letterman could be serious, dry and cerebral. But he often volunteered for oddball pranks. In one well-known stunt, he worked

a shift at a Taco Bell in suburban New Jersey, taking pickup orders.

In another sketch, Letterman was dunked in water while covered in Alka Seltzer tablets.

Receiving the Mark Twain Prize for American Humour at the Kennedy Center, the national showcase for arts, Letterman, 70, was praised for his imagination, comic daring and heart.

Many younger comedians, including current late-night host Jimmy Kimmel, have described Letterman as a major influence.

Before Kimmel's on-stage tribute to Letterman, the entertainer recalled one of his favourite, offbeat moments. "Dave

brought this doorknob out. And he put it on a table. And he said 'It's just plain big.' That was it."

Letterman hosted more

than 6,000 episodes of his original "Late Night with David Letterman" on NBC and its successor on CBS, "Late Show with David Letterman," which ended its run in May 2015.


He won multiple Emmy Awards, US television's highest honour, for his work as a writer, performer and producer.

The Indiana native made his first of 22 appearances on "The Tonight Show Starring Johnny Carson" in 1978. After hosting "Late Night" for 11 years, he moved to CBS in 1993 after losing out to longtime rival Jay Leno to succeed Carson at "The Tonight Show". On Sunday, comic friends

teased Letterman about his late-night wars with Leno and retirement but the honoree struck a poignant note in his acceptance speech. "Mark Twain's definition of patriotism is this: Patriotism is supporting your country all the time and your government when it deserves it."

In 2012, Letterman was recognised for his contributions to the arts and American culture at the Kennedy Centre Honours, a lifetime achievement awards for performing artists.

The Letterman tribute will be aired on public television stations on 20 November. —Reuters ■

## Armani plans transfer of stake in fashion firm to his foundation

MILAN — Giorgio Armani's succession plans include a transfer of part of his high-end fashion empire to his charitable foundation in a bid to prevent any takeovers or a break-up of the group, the designer told a newspaper.

Last year, Armani, 83, created a foundation in his name which said he planned to lead for the rest of his life.

With an estimated fortune of close to \$6 billion, he is still active in what is Italy's second-largest fashion group, but has not named a successor.

"What has been created is a mechanism that will encourage my heirs to maintain harmony and will avoid the group being bought or broken up," Armani told *Corriere della Sera* daily in an interview published on Monday.

Armani's does not have children of his own. His nieces Roberta and Silvana both work at the group while their cousin, Andrea Camerana, recently left but is still a board member. Long-time assistant Pantaleo Dell'Orco heads the men's lines and sits on the foundation's board.

"Believe me it is horrendous having to decide what to leave, whether it's fair or not, and every five minutes having to confront the reality of a man to whom something could suddenly happen," he said.

Under his succession plan, the foundation, which already owns 0.1 per cent of the Giorgio Armani holding company, will take a bigger stake, Armani said, without giving further details.

The remaining shares will be held by his heirs, who can only sell their holdings to the foundation.

Management will not be given shares in the group, Armani said.

The veteran fashion designer said last months that the image of his brand might benefit if he picked a successor, who did not necessarily have to be Italian.

But although he said that he would designate three people to succeed him at the foundation, it still remains unclear who will replace him at the helm of the Armani group.

Armani said the foundation, which will also be investing in charity, will have the final say in case of hung decisions by the company's board.

After a 5 per cent fall in revenues in 2016, Armani said he expected sales to fall by the same amount both this year and next, but to start growing again from 2019.

The group's cash position will improve to 1 billion euros at the end of this year, up from 880 million euros in 2016. —Reuters ■

## Enthused by Wi-Fi hotspots, Cubans clamor for more Internet access

HAVANA — At dusk, when the worst of the Caribbean heat has subsided, parks around Cuba fill with families video chatting with loved ones abroad or scrolling through social media, their animated faces lit by telephone and tablet screens.

The introduction of Wi-Fi hotspots in Cuban public spaces two years ago has transformed the Communist-run island that had been mostly offline. Nearly half the population of 11 million connected at least once last year.

That has whet Cubans' appetite for better and cheaper access to the internet.

"A lot has changed," said Maribel Sosa, 54, after standing for an hour with her daughter at the corner of a park in Havana, video chatting with her family in the United States, laughing and gesticulating at her phone's screen.

She recalled how she used to queue all night to use a public telephone to speak with her brother for a few minutes after he emigrated to Florida in the 1980s.

Given the relative expense of connecting to the internet, Cubans use it mostly to stay in touch with relatives and friends. Although prices have dropped, the \$1.50 hourly tariff represents 5 per cent of the average month-

ly state salary of \$30.

"A lot more could change still," said Sosa. "Why shouldn't we be able to have internet at home?"

A tiny share of homes has had broadband access until now, subject to government permission granted to some professionals such as academics and journalists.

The state telecoms monopoly has vowed to hook up the whole island and connected several hundred Havana homes late last year as a pilot project. In September, it said it would roll that service out nationwide by the end of 2017.

Cubans say previous promises for such access have not been fulfilled, so their expectations are not high. They also say the cost is prohibitive, with the cheapest monthly subscription priced at \$15.

Havana says it has been slow to develop network infrastructure because of high costs, attributed partly to the US trade embargo. Critics say the government fears losing control.

Cubans who can afford it flock to Internet cafes and 432 outdoor hotspots where they brave ants, mosquitoes and the elements.

Here they laugh, cry, shout, and whisper. Black market vendors weave in and out among

them, trying to hawk pre-paid scratchcards allowing Wi-Fi access.

The ping of incoming messages and ring of calls fill the air.

"There's absolutely no privacy here," said Daniel Hernandez, 26, a tourist guide, after video chatting with his girlfriend in Britain.

"When I have sensitive things to talk about, I try shutting myself into my car and talking quietly."

The quality of connections is often good only at specific spots, he said, and when fewer users are connected. Otherwise, the screen tends to freeze mid-chat.

Hernandez said he also uses the internet to search for news. In Cuba, the state has the monopoly on print and broadcast media.

A few meters further on, Rene Almeida, 62, sat in his taxi checking email. He said he felt lucky that his two children had moved to the United States where communications are better than ever. It was only in 2008 that the government first allowed Cubans to own cell phones.

He, too, complained of the lack of privacy and the expense.

"It's better than nothing," he said. "But it should improve. It will." —Reuters ■

## North Korea, Malaysia to play Asian Cup ties in Thailand

KUALA LUMPUR — North Korea and Malaysia will play their Asian Cup qualifying matches in neutral Thailand, the Asian Football Confederation (AFC) said on Tuesday, after earlier attempts to stage the matches fell victim to political tensions. Diplomatic relations between the countries

have been strained following the assassination of Kim Jong Nam, the estranged elder half-brother of North Korean leader Kim Jong Un, at Kuala Lumpur International Airport in February. In the wake of the killing, Malaysia barred its citizens from travelling to North Korea, which prevented

the national team from playing a qualifier originally scheduled for 28 March in Pyongyang.

While the exact venue and time of the fixtures has not yet been fixed, North Korea's 'home' match will take place on 10 November and the return tie three days later.—Reuters ■
