State Counsellor discusses literary fiction with university students

HE State Counsellor and Yangon university students held a discussion on literary fiction in the Yangon University Convocation Hall yesterday afternoon.

The discussion on literary fiction was attended by State Counsellor Daw Aung San Suu Kyi, Union Ministers Dr. Pe Myint, Dr. Myo Thein Gyi, Dr. Myint Htwe, Dr. Win Myat Aye and Nai-Thet Lwin, Yangon Region Chief Minister U Phyo Min Thein, region Hluttaw Speaker, Region Government Ministers, Rectors of universities and colleges in Yangon, teachers, students, youth organizations and youths.

State Counsellor Daw Aung San Suu Kyi conducted the discussion on literary fiction with Maung Bo Bo Hein from University of East Yangon, Maung Ar Man Htat and Ma Khaing Swe Zin Thet from Yangon University of Education, Maung Min Thant Htoo, Maung Min Aye Chan Ko and Ma Khin Khant Khant Chaw from Yangon University of Medicine 1, Maung Htat Naing Aung and Ma Aye Min Thwe from Yankin Education College, Maung Aung Kyaw Sint and Ma Wint Myat Noe from Yangon Technological University, Maung Thant Thura Zan and Ma Yi Mon Aung from Yangon Institute of Economics, Maung Kyaw Lin and Ma Yun Pwint May Thu from Yangon University, Maung

Min Khant Maung Maung from Technological University of West Yangon, Maung Kaung Htat Myet from Institute of Information Technology, Maung Zaw Lin Naing from Dagon University, Ma Than Thar Cho The from Yangon University of Medical Technology, Ma Aye Sandar Aung from National Management Degree College, Ma Chae Yati Myint from Yangon West University, Ma May Yadana Oo from Yangon University of Foreign Languages and Ma Thin Thin Thaw from Yangon University of Medicine 2.

State Counsellor Daw Aung San Suu Kyi started the discussion by saying, "I want to start the discussion with why this talk on literary fiction is being conducted. Not much need to be said on why people are taught and read non-fiction (scientific) literature. This is related to knowledge and to subjects we are formally taught."

How does literary fiction support our education? It teaches us not only the subjects we are taught but also about life, living and existence. Saya Pe Myint discussed with me about holding a discussion on how literary fiction supports us. Our country is a developing country that just started on its path towards development and is not financially strong. But everyone, every society, every organization has their own strengths, weaknesses and

advantages.

What makes a developing country that just started on its path towards development become strong? It is soft power or the power of the arts. That is why I discussed with Saya Pe Myint on encouraging arts.

Everyone in Myanmar as well as the world knows that the Korean drama series are influencing us with its soft power. We discussed on what sort of drama series or movies that would show our subtle soft power and we arrived at literature. Which novel should we make it into a movie? Which folklore should be made into a movie series? As we discussed this, Saya Pe Myint expressed his wish to conduct a discussion with youths on literary fiction and it ended up as this event.

When we look at the topics proposed by youths, we found that there were many subjects as their interest varies. But they all have one thing in common. That is the desire to talk.

Youths came up with a selection of about 15 to 20 books. We needed to narrow this down and from talks I had before, I found that Saya Mya Than Tint's "Crossing amount a in of swords and a sea of fire" came up at the top. This was followed by Saya Mya Than Tint's translation of "The Catcher in the Rye" and "Lover of Lingadipa" (by Chit Oo

Nyo). These three books came up as the top three favorite books. Before we discuss about whether we like these three books or not, let us see if there is anything common or connection in these three books.

Saya Mya Than Tint wrote forwards to his two books as well as "Lover of Lingadipa." In his forward to "Crossing a mountain of swords and a sea of fire" he said the novel is based on four main characters and he used them to express his views.

In his forward to "Lover of Lingadipa" Saya Mya Than Tint discussed about Ramayana. He didn't discuss about his view, historical view and folklore view but said Saya (author) Chit Oo Nyo is indeed a good author.

So let us talk about what a novel is and what sort of a person is the author. How effective was he in exposing his views through the characters in the book?

Let us talk about the importance of the characters in the book. There is a theme (a story) and there are characters. Some say the theme is important. Some say the characters are more important. Some say both. Which is more effective? Based on the novel you read, discuss whether it is a theme or character based. **Ma Yi Mon Aung, Yangon Institute of Economics**

I want to talk about my favorite novel "I came from southwest" written by Sayama Ponya Khin. It is about how a family was broken apart by Cyclone Nargis. The novel greatly affected my life and the lead character was the lone survivor of the family. She was devastated for four or five years but gradually her life returned to normalcy by the help of an educated person from Yangon who saved her.

What do you think about the story that was based on the views and thoughts of the characters? Ma Wint Myat Noe, Yangon Technological University

Both the story and the characters are important. Readers get thoughts and views through the thoughts and views of the characters. Another thing is the personality of the characters. It changes our lives.

How many of you have read "The Catcher in The Rye?" Why do you like it?

Maung Kaung Htat Myet, Institute of Information Technology

This book shook the world. I like this book due to the personalities of the characters. People can't be controlled and they change or learn through their mistakes. This is the main thinking of the character in this book. **Maung Min Thant Htoo, Yangon University of Medicine 1**

When I read the translation by Saya Mya Than Tint, I saw myself in the book. I learnt that we have the same thoughts at the same age.

Maung Min Aye Chan Ko, Yangon University of Medicine 1

I don't like "The Catcher in The Rye." It is just an ordinary book about the situation and mindset of youths anywhere. Saya Aung Khin Myint's "Essences that do not exist" really depicts the mindset of youth.

The literary fiction should resolve both of these reasons. It helps you understand your own culture as well as make you aware of and understand other cultures. If you only read about yourself and your culture, you'll be too narrow-minded.

The book I like best is "A person like him" by Sayama Journal Kyaw Ma Ma Lay. The message I got from this book is that you don't need to get out in the front or to be well-known to do what is good for the country. I learnt from the character in this book that you can do a lot for your country without trying to be famous or well-known.

"A person like him" is literary fiction and non-fiction (biography). The book depicts political movement and literature of that age. U Zaw Htay, Spokesman of the Office of the President: the questions have been raised as to the reasons for the removal of the Facebook accounts and pages associated with Tatmadaw

STATEMENT has been released by the Social Networking companybased in the US that Facebook has removed several accounts and pages associated with the Tatmadaw and other related personnel in Myanmar. It said that Facebook has removed 18 accounts and 52 pages associated with the Tatmadaw, according to the statement.

The Government didn't know beforehand about it

U Zaw Htay, a spokesman of the Office of the President said, "The first thing is that I was at the meeting with local business leaders the whole day, and later found out the statement released by the Facebook team after the meeting. It was said that 18 accounts together with 52 pages had been banned because of the violation of the community standard. When we review the community standards of the Facebook, it is found out that there are some screenshots, and the Government didn't seem to know about it in advance. The second thing is that we have many questions to be raised regarding the removal of these Facebook accounts and pages, such as: why did they ban, further details on the reasons of banning, and how can we retrieve these accounts and pages from the side of the relevant persons? The third point is who would make the approval regarding the violation of the community standard in the long term. We have learned that Myawady news and its relevant pages were banned. The main thing I want to mention is that there is nothing to do with the Social Media Monitoring Team (SMMT) as of the government body. We have seen that there were some fake statements and orders released by the President's Office on Facebook. They had removed our pages, and we also asked for the reasons when we were in need of some information and encounter many inconveniences. By the time Vice President of the Facebook arrived in Myanmar, we managed to discuss regarding these issues.

Discussion with Facebook again

"We, especially, made many discussions on information and several agreements between the Government and Facebook Team. But it hasn't completed it yet. We are going to make discussions with them by the time they come again in Myanmar."

"Regarding the violation of human rights issues, our government had already mentioned it clearly. The first point is that the government has zero tolerance for human rights violations. The second point is that the government had already said three points beforehand when dealing with the Rakhine issues. First, precautionary measures have to be made for both of Tatmadaw and police force, aiming to abide by the laws and regulations, and not to violate the human rights. If there is any cases against human rights, just give us strong evidence, record and date so that we can undertake the investigation into it.

Moreover we can proceed the procedures that can take legal action against to those who break the rules and regulations. We have already formed the Independent Commission of Enquiry to carry out the implementation process."

"Another point is that Fact-Finding Mission (FFM) report is to be submitted on 18 September. The United Nations Security Council hold a briefing on Myanmar on 25 August that is

marked the one-year anniversary of the ARSA terrorist attacks in Rakhine State. As far as I can see, this FFM report would issue prior to the meeting. The second point is that FFM was formed with the resolution of the Human Rights Council. Our government has spoken openly to the world that we dissociate the resolution of the Human Rights Council, as a consequence, we haven't taken part in it and denied it either. We didn't allow the FFM to enter into Myanmar, that's why we don't agree and accept any resolutions made by the Human Rights Council.

As I mention before, a report has been launched and submitted by FFM, thereby they attempted to remove the Facebook accounts and pages. So it is evident that all these situations have inter-relationships with one another. Our stance is clear and I want to say sharply that we don't accept any resolutions conducted by the Human Rights Council. The second point is that our country has accountability and responsibility framework regarding the human rights issues. Also Myanmar has zero tolerance to any human rights violation, and there is no exception on it.

Carrying out the finding of the investigation commission

The second point is that we shall take into legal action against any violation of human rights. The third point is that we have formed the Independent Commission of Enquiry to response to false allegations made by the UN Agencies and other international communities, and we are aware of it and going to carry out the process according to the findings and report of the Enquiry Commission. Our government has made pledges to tackle these issues by implementing the process

Regarding the removals of

the Facebook accounts, we have made inquiries to the Facebook for further details on the reasons for the ban. We fear of the government's efforts with regard to national reconciliation and peace process in Myanmar. There may arise some misunderstandings due to the impact of the SMMT. The first point is that the Facebook said it was removing several Facebook accounts, including Commander-in-Chief from the social media websites and pages. The second point is that there is no government involvement in this case. The third point is that the government is nothing to do with the SMMT. Thus we raised some questions to the Facebook regarding this case.

In the face of mounting criticism and fear among the people, the government also wants to characterize what is going on in the country, and discussions are being made to deal with this issue. There isn't any branch office of Facebook in our country, but we use it as users in the World Wide Web – www. As for the government, negotiation had been made to sign MoU with the Facebook, and plans are under way to reach the agreements between the government and Facebook Team.

Another thing is that Facebook becomes one of the social media as well as main stream media in Myanmar. Increasingly Facebook has been a useful instrument for those seeking to get information, in a context where for most users Facebook is the Internet. There is no doubt that Facebook has both its pros and cons. As for the government, efforts should be made to enact the Cyber Law in order to safeguard the security and to prevail rule of law for the interests of the people in the long run.

Nearly 3,000 Yaba tablets seized in Bago

Sharing love with the soft power of literary fiction

HE term "soft power" is considered to be derived from the arts, and Myanmar, which is a developing country, needs such kind of soft power to be stronger.

The term "soft power" is widely used in foreign policy debates and it is defined as the ability of a country to persuade others to do what it wants without force or coercion.

Successful states need both hard and soft power - hard power being the ability to coerce others as well as the ability to shape their long-term attitudes and preferences.

Today, the ability of soft power to influence the world is borne out by the Korean movie series. Meanwhile, literary fiction remains important.

We think literary fiction is more important than ever in today's world because it helps people escape from the never-ending news cycle by immersing themselves in great stories and complex characters.

We believe that literary fiction can help the readers understand deeply our own culture and understand the cultures of communities different from us as the arts bring expression in the context of different regions, territories, cultures, local circumstances or even challenges faced around a particular issue.

Literary fiction places the reader in other places, other times and other skins

In yesterday's talks between State Counsellor Daw Aung San Suu Kyi and

students over literary fiction, the students voiced that reading a good literary fiction make them better able to connect with others, enhances their ability to detect and understand other people's emotions, a crucial skill in navigating complex social relationships

It shows that literary fiction is very powerful. It can change society. But, readers ought to be able to experience stories from all parts of society, not just from privileged corners of it.

Hence, the goal of literary fiction should be: to make diverse voices heard and to bring out different opinions from different societies.

The art of literary fiction flows between love and hate, admiration and denouncement, pleasure and pain.... influencing the feelings of readers.

Let's make the best use of the power of literary fiction to change hate to love and conflicts to peace.

T was during the days early 1950s when our nation including rural areas saw the recession. At that time. there were no enough schools let alone libraries.

To make matters worse, due to the insurgency, peace and stability did not prevail throughout the country. We were brought up while the governemnt troops and destructive elements were playing hide-and-seek, killing each other in those days. Severe exchanges of fire between the government forces and the insurgents were very common to us.

In such a situation, how could we widen our horizon? How could we take happiness in reading? How could we build a learning society? No reading rooms. No reading materials. As for us, we had completely to rely much on the monasteries where we pursued monastic education. Members of the Sangha taught us primary education simply because most of us were not able to go in for formal education at government schools - primary, middle, and high schools - for various reasons.

Because of the teaching monks, we came to know how to read and write. However, we had no access to the place where we could continue to read and write.

Before long, we could see a silver lining in the dark clouds of those days. It was nothing but a so-called library that emerged in our ward. It was not much more than a reading room known as only a single library called "Linyaung-chi," or "Glean of light."

When I was sent to State High School, our school library attracted me when the class was in recess. The school library was larger than the one we had in our ward. To my memoirs, there was only a reading room run by Information Department known as Information and Public Relations Department (IPRD) today. No matter how they were called reading rooms, reading centres, or libraries, they were the storehouses of knowledge. could seek knowledge. Actually, they promote our lives!

It seems like just yesterday or the day before yesterday that we had lived in the undeveloped society.

According to historical records, the library movement in Myanmar began at the beginning of the Bagan Dynasty. King

knowledge among the courtiers and laymen.

Then again in the 18th Century, a year after ascending the throne, King Bodawpaya took an inventory of the inscriptions, palmleaves and parabaiks and caused copies to be made in order to launch the library movement. Such an undertaking was not only advantageous to laymen of those days but also a treasure to hostorians. There is no reason to doubt that due to the farsightedness of the Myanmar kings, the library movement gained momentum to an appreciable

During the colonial period, the aims of the movement faded out. However, even during the war, a group of devoted literary men continued the task of They were the places where we creating Myanmar manuscripts while working in the Bureau of Libraries and Literature of the Directorale of Education. People like U Thein Han (Saya Zaw Gyi) carried on this work. Yet after independence, I was told that because of lack of patronage, the movement was not revived. The task was resumed only in the wake of the nationwide litin A.D. 1058 for the purpose of statistics gathered for the Interspreading cultural and religious national Book Year (1972), there

were no less than 700 libraries all over Myanmar at that time. In the time of U Thein Sein Government, a total of 55,755 village libraries were opened nationwide. I was flabbergasted.

When I moved to Yangon to work as a junior clerk in the Telecomminication Department (South Burma) in 1967, my office was not far from the Sarpay Beikman Public Library and the National Library. Since then, these libraries have became my treasurehouses. And the librarians also became my mentors who taught me how to use catalogues and helped me visit the world of books.

Sarpay Beikman Public Library was a first and foremost free public library opened in the post-independence period. It was established on 13 March, 1956 in the Sarpay Beikman Building (at 529-531, Merchant Street in Kyauktada Township, Yangon.) It was one of the few free public libraries in Myanmar. It was learnt that the library attracted from 200 to 450 readers daily in its early days. It had nearly 13,000 books, both English and Myanmar. When I joined the Worker's

During my stay in Washing ton D.C in 2016, I happened to visit the Library of Congress. According to the pamphlet they gave me, the Library of Congress is the world's largest repository of knowledge and creativity, with a growing collection of more than 162 million items, including books, print materials, sound recordings, photographs, maps, sheet music, motion pictures and manuscripts in more than 470 languages. I was told that the library of Congress was established in 1800. (I wish I had such a library in our country.)

Now, we can be proud of the National Library (Nay Pyi Taw) which is located near the Kumudra Circle in Ottra Thiri Township, Nay Pyi Taw. The foundation was laid down in 2010 and the library was open to the public in 2013. The National Library of Myanmar is one of the national level institutions of the country under the auspices of the Ministry of Culture. The Library provides the services of reference, reading room, periocicals, children corner, photocopying, library and the Internet.

Although Nay Pyi Taw, the capital city of Myanmar, can possess the national image, as for Yangon, the commercial city, when?

On 28 July, 2016, a coordination meeting took place at the Presidential Palace in Nay Pyi Taw to discuss the relocation of the National Library to a convenient environment in the commercial hub of Yangon City. The meeting reached an agreement to move the library from Yankin Township to Pabedan Township. To be objective, the new location of the National Library will be at No.604/608 Merchant Street, Pabedan Township in Yangon.

Due to the ups-and-downs of life, the library was moved to two new locations before setting in Tamway Township. The library building in Tamway suffered some damages from the Cyclone Nargis in 2008. As a result, it was move to Yankin Township which is rather far from downtown Yangon.

Being a book lover, I for one, have been longing for a grand and impressive one in Yangon. Be patient! It is in the offing!

The Vice President said Myanmar needs reliable data for setting fact-based policies, prioritized sectors, designing strategic plans and monitoring efforts. He thanked the Danish Ambassador and UNU-WIDER for providing financial and technological assistance.

The MSME Survey includes over 71,000 commodity production businesses and highlights the needs for the development of SMEs and to increase their competitiveness while identifying their difficulties, said the Vice President. He added that the survey included invaluable data that charts a detailed map of the SME sphere in Myanmar.

This survey also included data related to employees that shows the correlation between wages and the demand of the workforce and available skillsets, said the Vice President. From this he sees the need for more training schools to increase the workforce capacity.

The Vice President said technological support was needed for Myanmar SMEs to produce high-quality commodities, as well as encouragement for pioneers, innovation, creativity and exploring new markets. He said only then will the country replace imports with local products and drive up export rates as well. He said Myanmar was implementing the 12-point economic policies which included SME development. He said it was important to change to a 'from data to policy' approach so that the private sector was strengthened.

According to the 2015 Myanmar Economic Survey, the manufacturing sector made up the bulk of the economic sector at 40 per cent, while 90 per cent of the businesses in Myanmar were small businesses, said the Vice President. He added that only 2 per cent of businesses in the country employ more 250 more staff.

This clearly outlined how SMEs were the fundamental building blocks for developing Myanmar's economy, said the Vice President, adding that the SME Development Central Committee and Working Committees were formed to address this objective.

The Vice President said the manufacturing sector created more job opportunities than other trade sectors of the service sector. He said producing high quality products would drive up the manufacturing sector. He concluded by thanking everyone involved in making the MSME 2017 Survey a success.

Next, Union Minister for Commerce Dr. Than Myint explained about the requirements and difficulties faced by MSMEs in their self-development.

This was followed by the

Cherge d'affairs of Denmark Embassy Ms. Dorte Chortsen explaining the benefits of conducting surveys in supporting a country's economic development.

The Vice President then took a documentary photo with the participants.

The event continued with the Director-General of the Central Statistical Organization, Dr. Wah Wah Maung, and UNU-WIDER lead researcher Mr. Finn Tarp explaining the central findings and policy advice found in the MSME 2017 Survey.

The Nay Pyi Taw Council, state and region Ministers for commerce then presented and discussed about acquiring loans and advices for MSMEs. Deputy Minister for Planning and Finance U Sett Aung the delivered the closing speech and ended the event. Attending the event were Union Ministers Dr. Aung Thu, U Thant Sin Maung, U Win Khaing, Dr. Than Myint and U Han Zaw, Nay Pyi Taw Council Chairperson Dr. Myo Aung, deputy ministers, commerce ministers from the Nav Pvi Taw Council, states and regions, Cherge d'affairs of Denmark Embassy Ms. Dorte Chortsen, officials from UNU-WIDER, department heads, and officials from joint-development organizations, NGOs, humanitarian and civil groups. — Myanmar News Agency 🔳

Millions risk malnutrition as CO₂ levels climb

PARIS — Rising levels of carbon dioxide in the air threaten to sap wheat, rice, and other staple grains of valuable nutrients, raising the spectre of mass malnutrition, researchers warned on Monday.

On current trends, higher CO_2 concentrations could reduce iron, zinc and protein levels in the crops that feed the world by up to 17 per cent by mid-century, they reported in the journal Nature Climate Change.

"Hundreds of millions of people could become newly deficient in these nutrients, primarily in Africa, Southeast Asia, India and the Middle East," lead author Matthew Smith, a researcher at the Harvard TH Chan School of Public Health, told AFP.

"These are in addition to the billions of people already deficient that could see their condition worsen." Protein, along with the minerals iron and zinc, are essential nutrients for normal human growth and development. Zinc deficiency affects the immune system and makes children, particularly, more vulnerable to malaria, lung infections and deadly diarrhoeal diseases.—AFP

Out of the information sent to the Ministry of Home Affairs, so far 185 cases have been opened as of 25-8-2018, and 244 men and 49 women have been arrested with seizures of 1,904.79 g of heroin, 1.35 g of ICE, 311.65 g of black opium, 31,436.50 g of raw opium, 50.50 g of low-quality opium, 27.50 g of opium residue, 1,502 g of powder opium, 3,266 g of speciosa, 92,017 stimulant tablets, 1,766.08 g of marijuana, 0.10 liters of opium tincture, 213.40 g of opium blocks, 60 g of poppy seeds, and 3 different types of firearms. Efforts for fighting the drug trafficking has been stepped up and the ministry will report on further exposed cases.
- 4. In addition to the investigations and arrests conducted on drug related complaints mentioned above, the Tatmadaw and Myanmar Police Force have also carried out separate investigations on drug complaints, search and arrests at border gates, and searches of vehicles acting upon given information.

In the past week, Tun Tun Oo (a) Sithu (a) Pyaung Gyi, who is guilty of carrying illegal drugs in Nay Pyi Taw, was arrested. Police seized 126 stimulant tablets and 7.02 g of ICE from his hotel room No.221 in Hotel Shwegondaing in Hotel Zone 2.

In Shan State, Mabein Twp, Lawa Village-tract, Kyauklonegyi forest, police searched suspicious looking huts and arrested 3 male suspects with 30 g of heroin, 40,200 stimulant tablets and 2 rifles. In Pinkyein Village police arrested 1 male suspect together with 210 stimulant tablets, 1 g of heroin and 1 rifle. In Moemeik Twp, Latkotdan Ward, police arrested 1 male suspect with 17,000 stimulant tablets. In Ward 14, Namkham City, a female suspect was arrested with 3,864 g of heroin and 79,230 stimulant tablets. In Kutkai Twp, 5,000 meters to the east of Kaungkar Village, local police searched five vacated huts in the area and

discovered equipment for concocting drugs including acid barrels, gas tanks, electric stoves, fire extinguishers, pipes, tarpaulin, etc.

In Rakhine State, Buthidaung City, two male suspects were arrested with 1,352,750 stimulant tablets. In Taungkot Twp, one male and one female suspect were arrested with 1,980 stimulant tablets. In Kyauktaw Twp, Teyatapin Village, a female suspect was arrested with 12 stimulant tablets. In Mrauk-U City, Htamra Ward, two male suspects were arrested with 510 stimulant tablets.

There have been two cases of drug seizures involving foreigners. In Shan State, Tachileik City, four illegal Thai immigrants were arrested with 80 stimulant tablets, 53.5 g of ICE, 2 pistols with 32 bullets and 3 cartridges. In Kayin State, Kyarinseikgyi Twp, Payartonesu, three Myanmar men, one Thai man and one female suspect were arrested 5,252 stimulant tablets, 1,330.52 g of ICE, 1 pistol with 16 bullets and 1 cartridge.

There have been 3 cases of arrests involving firearms. Six male suspects were arrested with 69.3 g of heroin, 85 g of raw opium, 1,090 stimulant tablets, 5 firearms, 357 bullets and one cartridge.

There has been one case of retaliation to resisting law enforcement. In Sagaing Region, Banmauk Twp, Thaunggyi Village, two male suspects were shot by police, sustaining nonfatal injuries, in response to their retaliation with firearms. Police seized 2.4 g of heroin, two rifles and an axe.

There have been 335 cases being opened between 19-8-2018 and 25-8-2018, and 428 men and 48 women have been arrested. Seizures of 4,976.19 g of heroin, 3,566.33 g of ICE, 22,087.49 g of raw opium, 45 g of low-quality opium, 1,580 g of powder opium, 1,692,177 stimulant tablets, 127.04 g of marijuana, 7,301.5 g of opium blocks, 0.05 g of opium tincture, 169 ecstasy tablets, 13 diazepine tablets, chemical batches, drug concocting equipment, 13 firearms, 450 bullets, and 5 cartridges.

Fish oil supplements don't prevent heart disease in people with diabetes

WASHINGTON - Fish oil supplements do not help prevent heart attacks or strokes in people with diabetes, said a study on Monday that adds to a growing body of research on the ineffectiveness of pills containing omega-3 fatty acids.

More than 15,000 people with diabetes but no signs of heart disease enrolled in the study in Britain, the results of which were published in the New England Journal of Medicine.

Half the participants were given a daily capsule of omega-3, while the other half received a placebo pill containing olive oil. The study was randomized and blinded, meaning that participants had no idea which they were taking.

Patients were followed for an plements." average of just over seven years.

Among those taking fish oil pills, 8.9 per cent suffered a heart attack or stroke, compared to 9.2 per cent in the placebo group, which was not a significant difference.

"Our large, long-term randomized trial shows that fish oil supplements do not reduce the risk of cardiovascular events in patients with diabetes," said principal investigator Louise Bowman of the University of Oxford.

"This is a disappointing finding, but it is in line with previous randomized trials in other types of patient at increased risk of cardiovascular events which also showed no benefit of fish oil sup-

Bowman concluded: "There is no justification for recommending fish oil supplements to protect against cardiovascular events."

In January, an analysis of 10 studies involving 78,000 people published in the Journal of the American Medical Association (JAMA) Cardiology also concluded that fish oil pills did not prevent heart disease among people at high risk.

Some observational studies have pointed to an association between higher consumption of fish and lower risks of coronary artery disease and stroke, but more rigorous, randomized trials have not supported this link. -AFP

Startup delivers groceries in self-driving cars

SAN FRANCISCO — Startup AutoX on Monday announced the Silicon Valley debut of a service that will turn self-driving cars into mobile grocery shops summoned with a touch of a Xiao. smartphone application.

The service will kick off this month in parts of the California city of San Jose in a partnership with e-commerce company GrubMarket.com which sources food from producers as well as retail shops such as Amazon-owned Whole Foods.

"We're very excited to launch the first autonomous gro-

cery delivery and mobile store service in the heart of Silicon Valley with self-driving vehicles and chief executive Jianxiong

"We believe self-driving car technologies will fundamentally change people's daily lives for the better."

The AutoX application can be used to place grocery orders to be delivered in cars designed to keep produce chilled, according to the startup.

Customers uncertain of what they want in advance will

also be able to have cars pull up and open windows so they can browse selections, AutoX said. on the road," said AutoX founder A human back-up driver will be on board as required by local regulations.

AutoX vehicles rely on high-resolution camera gear instead of more costly sensors and laser arrays for navigation.

The grocery delivery and mobile store pilot program will roll out in San Jose, then expand to Google's home city Mountain View and Palo Alto, where Stanford University is located. -AFP

Zvezda soon to be able to manufacture spacesuit for Mars in 3-4 years

MOSCOW — Russian Research & Development Production Enterprise Zvezda in the future will be able to produce a fundamentally new spacesuit for flights to Mars in three or four years, press service of the company told TASS.

"At the moment, there is no work on the Martian spacesuit. Some time ago, on our own initiative, we worked out a life support system on liq-

uefied oxygen for the Martian spacesuit. We believe that by the time of a flight to Mars, fundamentally new materials and technologies will appear that allow to make a fundamentally new spacesuit in 3-4 years," the press service said.

Earlier SpaceX CEO Elon Musk, who plans to send the first colonists to Mars in the near future, presented a concept of the Martian spacesuit.—Tass 🔳

Aussie scientists use gold-plated nanoparticles to detect cancer signals

SYDNEY — A new diagnostic nitude cheaper," Gooding said. technique, using gold-plated nanoparticles, could make the detection of cancer much cheaper and faster, according to Australian scientists from the University of New South Wales (UNSW) who developed the method.

The scientists are now able to detect very low levels of microRNAs, linked with cancerous tumours and metastasis, in blood samples of significantly lower volumes.

"What this means is the technology has the potential to determine the levels of microRNA just from a finger prick test," Professor Justin Gooding from UNSW said.

The low levels of sample needed, as well as the efficiency of the process in detecting microRNAs, makes the method much easier than was previously required, as well as more financially feasible.

"It could be orders of mag-

"Our method takes 30 minutes compared with almost 12 hours for quantitative polymerase chain reaction.'

What make the new method so effective is the use of magnets to attract the microRNAs.

Scientists create gold-coated magnetic nanoparticles which latch onto a high portion of the present microRNAs, and then capture the nanoparticles and newly attached microR-NAs with a magnet.

"Because the capture is so effective, we get higher sensitivities and can detect much lower limits," Gooding said.

"And since we bring them back to the electrode under a magnet, our response time is much faster."

Gooding said he would expect the technology to be available within three years, pending regulatory approvals.—Xinhua

Mourinho calls for respect as Spurs pile more misery on Man Utd

LONDON — Manchester United manager Jose Mourinho called for respect after suffering the heaviest home defeat of his career as Harry Kane and a Lucas Moura double moved Tottenham joint top of the Premier League with 3-0 win at Old Trafford.

A second consecutive defeat piles even more pressure on the Portuguese coach as United now trail Spurs, Liverpool and Chelsea by six points and stand four adrift of champions Manchester City just three games into the new campaign.

The odds on Mourinho losing his job have been slashed in recent weeks as on top of adverse results, he has clashed with the club's executive vice-chairman Ed Woodward over a lack of signings.

However, he railed against his critics by citing his record of winning the Premier League three times over two spells at Chelsea.

"I won more Premierships

alone than the other 19 managers together. Three for me, two for them. Respect!" a fiery Mourinho raged at reporters on exiting his post-match press conference.

Mourinho stood in front of Old Trafford's Stretford End at the end of the game to applaud the home fans, who didn't boo his side at full-time despite the result. "Today I had the proof the best judge are the supporters," Mourinho said.

The fans and Mourinho's response came after a dominant

first 45 minutes from the hosts before Spurs took control with two goals in two minutes just after the break.

United, though, were left to rue a series of missed chances by Romelu Lukaku, particularly when the Belgian fired wide with an open goal on 15 minutes.

Second-half surge

Tottenham hadn't even scored in losing on their four previous trips to Old Trafford under Mauricio Pochettino.

Yet, the Argentine's half-time words of wisdom made a huge difference as Spurs came out a different side after the break.

David de Gea had already denied Kane and Dele Alli had seen a goalbound effort deflected wide by the time Kane rose highest from Kieran Trippier's corner to loop a header into the net.

Hugo Lloris kept his place in the Spurs goal and retained the captain's armband despite being arrested for drink driving in the early hours of Friday. — AFP

Nadal sends injured Ferrer into Grand Slam retirement

NEW YORK — World number one and defending US Open champion Rafael Nadal sent his close friend David Ferrer into Grand Slam retirement on Monday when his veteran compatriot was forced to quit their first round match with an injury.

Ferrer, a former world number three but now standing at a lowly 148, called it quits on a hot and humid night on Arthur Ashe Stadium when he led 4-3 with a break in the second set.

Top seed Nadal had taken the opener 6-3.

"This is my last Grand Slam," said Ferrer who was runner-up to Nadal in the 2013 French Open final. "I have great memories of this tournament and I am just sorry that I couldn't finish it tonight."

Ferrer, 36, will play his last tournament on home ground in

Madrid next year. "I am very sorry for David and sad for him," said Nadal.

"We are close friends and have shared great moments the Roland Garros final and Davis Cup wins.

"He is one of the greatest players to have come from our country. He's a great person and great player."

Nadal, chasing his 18th Grand Slam title, will face Canada's Vasek Pospisil for a place in the last 32.— AFP ■

Serena Williams returns in style at US Open

NEW YORK — Serena Williams made a triumphant return to the US Open on Monday, opening her bid for a recordtying 24th Grand Slam title with a 6-4, 6-0 first-round victory over Magda Linette.

Williams, a six-time champion at Flushing Meadows, missed last year's edition as she gave birth to daughter Olympia on 1 September.

She was all-business on her return under the floodlights on the Arthur Ashe Stadium court, where she has lifted the trophy six times. Linette, the world number 68 from Poland who was facing Williams for the first time, held her own in the early going.

But Williams broke her in the seventh game of the opening set to gain the upper hand and from there the American superstar rolled.

The first set was tight," Williams, seeded 17th, said. "It was my first match back here in New York so that wasn't the easiest.

"Once I got settled I started doing what I'm trying

to do in practice.

"I think I'm getting there," added Williams, who reached the final at Wimbledon only to fall short of matching Margaret Court's all-time record of 24 major titles.

She didn't face a break point in the 70 minute match, but as her momentum built her emotions burst out with fistclenched shouts of "come on". After Williams held serve from deuce for a 5-3 lead, Linette would hold to force Williams to serve out the set.

From there, it was all Williams as she raced through the second set in 28 minutes.

She next faces Germany's Carina Witthoeft, with a possible third-round clash with 16th-seeded sister Venus in the offing.— AFP
